Pomona Elections

- Mayor & Council Members hold 4 -year terms
 - Mayor & Districts 1, 4, 6 terms end November 2024
 - Districts 2, 3, 5 terms end November 2022

Redistricting Process

Step	Description
Initial Pre-Draft Hearing(s)	Held prior to release of draft maps. Education and to solicit input on the communities in the City. Identify "neighborhoods," "communities of interest," and "secondary areas."
Initial deadline for draft maps	Deadline for the public to submit draft maps for inclusion in the next hearing packet and presentation
Release draft maps	Draft maps posted to project website
Two hearings on draft maps	Two meetings to discuss and revise the draft maps and to discuss the election sequence.
Map adoption	Map adopted via ordinance/resolution. Final map must be posted at least 3/7 days prior to adoption.

 Equal Population Federal Voting Rights Act No Racial Gerrymandering 	 Geographically contiguous Undivided neighborhoods and "communities of interest" (Socio-economic geographic areas that should be kept together) Easily identifiable boundaries 	 Minimize voters shifted to different election years Respect voters' choices / continuity in office Future population growth Preserving the core of existing districts
	 4. Compact (Do not bypass one group of people to get to a more distant group of people) <i>Prohibited:</i> "Shall not favor or discriminate against a political party." 	

Timeline & Next Steps

- Due to delays in the release of the Census data, it is anticipated that full data sets from the Census Bureau will not be ready until late September or early October
- □ The approved map must be submitted to the LA County Registrar of Voters by no later than April 17, 2022
