# Redistricting Process

Step	Description		
<b>Two Initial Hearings</b> July 28 & August 25	Held prior to release of draft maps. Education and to solicit input on the composition of districts.		
Summer/Fall 2021	Residents provide initial feedback on "communities of interest."		
<b>Census Data Release</b> Mid-August	Census Bureau releases official 2020 Census population data.		
<b>California Data Release</b> Early October 2021	California Statewide Database releases California's official 'prisoner- adjusted' 2020 redistricting data.		
Release draft maps	Maps must be posted at least 7 days prior to 3 <sup>rd</sup> hearing.		
<b>Two hearings on draft maps</b> Dates TBD	Two meetings to discuss and revise the draft maps and to discuss the election sequence.		
Map adoption	Map adopted via ordinance. Must be submitted to LA County Registrar of voters by no later than April 17, 2022. Final map must be posted at least 7 days prior to adoption.








#### Asian-American CVAP


Asian-Americans have some concentration in District 5.

# Defining Neighborhoods

# 1<sup>st</sup> Question: what is your neighborhood?2<sup>nd</sup> Question: what are its geographic boundaries?

#### Examples of physical features defining a neighborhood boundary:

- Natural neighborhood dividing lines, such as highway or major roads, rivers, canals and/or hills
- □ Areas around parks or schools
- □ Other neighborhood landmarks

In the absence of public testimony, planning records and other similar documents may provide definition.



#### Beyond Neighborhoods: Defining Communities of Interest

1<sup>st</sup> Question: what defines your community?

- Geographic Area, plus
- □ Shared issue or characteristic
  - Shared social or economic interest
  - Impacted by city policies
- □ Tell us "your community's story"

#### 2<sup>nd</sup> Question:

Would this community benefit from being "included within a single district for purposes of its effective and fair representation"?

□ Or would it benefit more from having multiple representatives?

Definitions of Communities of Interest may <u>not</u> include relationships with political parties, incumbents, or political candidates.

# Possible Neighborhoods / Communities

- Downtown/ area around Civic Center
- Phillips Ranch
- North Pomona along Foothill Boulevard
- Communities along Garey Avenue

### Timeline & Next Steps

- Due to delays in the release of the Census data, it is anticipated that full data sets from the Census Bureau will not be ready until late September or early October
- □ The approved map must be submitted to the LA County Registrar of Voters by no later than April 17, 2022
