Chair Yañez Ruiz called the Independent Redistricting Commission Meeting to order at 7:00 p.m.

Commission Secretary Glynn explained the process for public participation in the workshop setting.

Chair Yañez Ruiz introduced the workshop and turned the meeting over to staff from Tripepi Smith and NDC.

Jennifer Nentwig from Tripepi Smith facilitated the workshop and encouraged the community to get involved. She indicated the intent of the meeting was to be an informal conversational session geared towards community members.

She shared the objectives of the workshop and provided an update on the outreach and engagement efforts conducted by Tripepi Smith.

Jeff Simonetti from NDC gave an overview of the redistricting process and indicated the next two meetings in January and February of 2022 would include discussion and review of the submitted draft maps. He explained the Commission would consider and approve the map in March and that the deadline to submit the adopted map would be April 17, 2022. He outlined the rules and goals involved in the redistricting process.

Mr. Simonetti continued the presentation on defining neighborhoods and communities of interest. He shared some of the demographic data available on the District R website and gave an overview of how to define neighborhoods and communities of interest. He

demonstrated how to access the mapping tool, communities of interest maps, and submitted draft maps on the District R website.

He asked if there were any questions regarding the presentation thus far.

Eunice Russell asked why the southwest portion of Ganesha Park was omitted from the "Ganesha Park & Areas Around Fairplex" community of interest map. Mr. Simonetti thanked her for the feedback and indicated he would add that portion into the final map.

Commissioner Mendoza asked why the section referenced by Ms. Russell was omitted in the first place and mentioned an area south of 10 freeway that could be included.

Commissioner Diaz asked about the omissions in the Phillips Ranch communities of interest map.

Eunice Russell said she did not understand Commissioner Mendoza's comment stating the section southeast of Ganesha Park could be included in another district.

Chair Yañez Ruiz pointed out the Commission was not determining what constitutes the different communities of interest like Phillips Ranch or Ganesha Park. He said the maps were just points of interest for the community and the Commission to consider in the map drawing process.

Jennifer Nentwig encouraged members of communities to submit their own community of interest maps for consideration.

She read a comment from the Q&A from Anne Tomkins stating she believed the historic districts were each their own communities of interest.

Anne Tomkins asked about the process of submitting maps and if the draft maps on the map page were official or just drafts.

Jeff Simonetti explained the process and indicated the map had to be shared to the gallery to be considered final.

He went through a few examples of the 19 maps that had been submitted thus far.

Anne Tomkins asked about the process to submit paper maps.

Mr. Simonetti said he would draw the paper maps received on District R so they could be viewed in the gallery.

Jennifer Nentwig explained the paper map kits could be found on the Draw Pomona website.

She invited participants to engage in Q&A with the hosts of the workshop.

Commissioner Diaz asked about the demographic breakdown on the submitted maps.

Jeff Simonetti demonstrated how to access the demographic sets for each map on the District R website.

Jennifer Nentwig pointed out that the Commission would receive a demographic summary of each map when it was time to review the submitted maps.

Chair Yañez Ruiz asked if the summary would also include other variables like median age, median income, and the education information of the voters.

Mr. Simonetti said it would be included and demonstrated how to access the data on the District R website.

Jennifer Nentwig reminded everyone that the Draw Pomona website was an invaluable resource for redistricting in Pomona and demonstrated a few of the resources available on the website.
